- P60's for full year/s that evidence is missing from. If you started work in the middle of a financial year you will need further evidence for the missing months.
- Current contract of employment
- Previous school registrations/prior education certificates
- 3 years continuous Payslips
- In-time applications to the Home Office for extension to leave (visa/permit)
- 3 years of bank statements showing payments of spending in the UK.
- A dated letter on headed paper from a UK GP stating that you have been a patient for the 3 years prior to the start date of the course and had regular
 appointments during those 3 years. (we do not need to see your medical history or the reason for your appointments).
- School reports addressed to you where the child, under 18, is in your permanent care and they are attending school, not remote teaching we will ask for the child's birth certificate to confirm your relationship.
- Evidence of 3 years of JSA
- Declaration from employer on letter header paper, dated and signed and evidence that your employer is genuine, for example, their Companies House number
- PIR
- Evidence of your self-employment in the UK; self-assessment return to HMRC for missing month/s/year/s showing the length of your previous employment. You should get a P45 from your employer when you stop working for them.
